DEFINITION

Under the direction of the Director Student Services, the District Nurse will conduct health services and health education for school age children and case managed families with children 0-5. The District Nurse will strengthen the educational process through the improvement of the health status and expansion of the knowledge base of the student. The District Nurse will function in accordance with state law, district policy and procedures, HIPPA, and the Board of Registered Nurses.

REPRESENTATIVE DUTIES

- 1. Plan and implement the district health program
- 2. Assist in the formulation and appraisal of policies, standards, objectives, and budget of the district health program
- 3. Perform mandated health related screenings and subsequent referrals and follow up
- 4. Identify students with health concerns that have a potential to interfere with effective learning and actively participates in the assessment, evaluation, referral, and planning process in order to facilitate optimum learning.
- 5. Assist with programs directly related to the control of communicable diseases and conduct immunization programs to assure students are in compliance with state law
- 6. Conduct in-service trainings and serves as a resource person to staff, students and the community in the areas of health and safety.
- 7. Serve as the primary manager of health care services for children in the school setting through referrals to appropriate community resources and maintaining communication with parents, and all involved community practitioners and agencies to promote needed treatment
- 8. Conduct health and developmental assessments for Initial and Triennial IEP Assessments
- 9. Complete developmental assessments and consultation services during home visits to case managed families with children 0-5 years of age
- 10. Provide accompaniment and consultation services to Family Advocates during home visits to case managed families
- 11. Supervise and monitor first aid administration at the school site and provide emergency response when necessary
- 12. Supervise and monitor medication administration at the school site
- 13. Design and implement health maintenance plans to meet the individual needs of students incorporating physician's plans as needed
- 14. Serve on Student Assistance Teams, IEP Teams, and 504 Teams as necessary to coordinate integrated health services
- 15. Serve as an active participant in implementing any section or sections of a comprehensive health and nutrition instruction curriculum
- 16. Acquaint school personnel with available resources in the community
- 17. Report health hazards observed; interpret and keep abreast with lows and regulations regarding the distirct health program
- 18. Complete required county and state health reports
