ELEMENTARY/MIDDLE SCHOOL CLASSROOM TEACHER CERTIFICATED JOB DESCRIPTION

DEFINITION

Provides an educational program for pupils in grades K- 8, or a combination thereof, and assists in other school programs as assigned; responsibility for evaluation of each teacher shall reside with the site principal.

MAJOR DUTIES AND RESPONSIBILITIES

1. Multi-subject: Teaches, as a team or self contained class the subjects prescribed by state and local regulatory bodies i.e. reading, language arts, social studies, mathematics, science, art, health, physical education, and music to pupils in a classroom, utilizing state standards course of study and curriculum and other appropriate learning activities adopted by the Board of Trustees, and State of California.
Single Subject: Teaches subject qualified within held credential utilizing state standards and state / board adopted curriculum for subject.
2. Instructs pupils in citizenship, basic communication skills, and other general elements of the course of study specified in state law and administrative regulations and procedures of the school district.
3. Develops lesson plans and instructional materials that addresses a variety of individual learning modalities.
4. Uses technology effectively in classroom instruction, in keeping appropriate records and preparing progress reports, report cards, benchmark assessments, etc.
5. Establishes and maintains standards of pupil behavior needed to achieve a functional learning atmosphere in the classroom- insures a safe learning environment. Knowledge and experience of grade level State Standards of single subject taught and or grade level.
6. Evaluates pupils' academic growth, and communicates with parents on the individual pupil's progress.
7. Assists in identifying pupil needs and cooperates with other professional staff members in assessing and helping pupils solve health, attitude, and learning problems.
8. Creates with assistance from pupils, a functional and attractive environment for learning through displays, bulletin boards, and/or interest centers.
9. Maintains professional competence through participation in required in-service education activities provided by the district and/or self-selected professional growth activities.
10. Performs basic attendance accounting and business services as required.
11. Upholds District Board Policies /Rules and Regulations.
12. Provides planned learning experiences in order to motivate pupils and best utilize the available time for instruction.

OTHER DUTIES AND RESPONSIBILITIES

1. Supervises pupils in out-of-classroom activities during the assigned working day.
2. Administers group standardized tests in accordance with district testing program.
3. Participates in curriculum and other developmental programs, including Professional Learning Community and Response to Intervention within the school of assignment and/or on a district level.
4. Shares in the sponsorship of student activities and participates in faculty committees.
5. May plan and coordinate the work of aides, teacher assistants, and other paraprofessionals.
6. Participates in school sponsored activities outside the assigned working day such as parent teacher meetings, Open House, Back to School Night, Holiday programs, Student Meetings; IEP, RTI, SST

Supervision Exercised or Received: Under the immediate direction of the site administrator, or delegated authority, evaluations will be completed in accordance to the local CTA contract.
